WINTERIZATION OF POOL: Includes lowering the water to the proper level, (WATER WILL BE PUMPED ON YOUR PROPERTY, WE CAN NOT PUMP TO THE STREET.) removal of accessories if necessary, draining the filter, pump, motor, and other pool equipment, blow the lines with air and inserting winterization plugs. Water level will be lowered 1-3" below tile for solid covers, and at least 6" below the tile for mesh covers. THIS SERVICE DOES NOT INCLUDE: any domestic freshwater lines unless agreed upon separately in writing. Pump and motor will not be removed unless specified by customer. Plugs, blocks, chemicals, or other necessary equipment will be provided at an additional cost if required. PLEASE HAVE ALL PARTS AT POOL SIDE, THIS INCLUDES COVER PUMPS, EXTENSION CORDS & HOSES. ADDITIONAL CHARGES IF WE NEED TO RETURN. Pools will be winterized in found condition. We are not responsible for items left on pool deck when we are completed. Additional charges may apply for larger pools.
