Test water and balance chemistry, Chemicals are extra. **Please have water level 1/2 way up the skimmer mouth & all the parts out so that the filter system can be started.** If the customer fails to raise the water level for our service, there is an additional charge for our technicians to return to start the filtration and cleaning system or relight the heater. Any repairs necessary will be billed in addition to the contract price. **There is an additional charge for multiple filtration systems.**
